





# **Severity Definitions**

Risk Level	Description
Critical	Critical vulnerabilities are usually straightforward to exploit and can lead to assets loss or data manipulations.
High	High-level vulnerabilities are difficult to exploit; however, they also have a significant impact on smart contract execution, e.g., public access to crucial functions
Medium	Medium-level vulnerabilities are important to fix; however, they can't lead to assets loss or data manipulations.
Low	Low-level vulnerabilities are mostly related to outdated, unused, etc. code snippets that can't have a significant impact on execution
Lowest / Code	Lowest-level vulnerabilities, code style violations,
Style / Best	and info statements can't affect smart contract
Practice	execution and can be ignored.

No Critical severity issues were found.

#### High

1. Vulnerability: Unchecked transfers in critical functions

ERC20 doesn't require a token to revert in the case of transfer/transferFrom failure, but it does require to return a boolean result of whether it succeeded.

Recommendation: Please consider adding a return value check.

#### Medium

No Medium severity issues were found.

#### Low

1. Vulnerability: Missing zero address validation

# Lowest / Code style / Best Practice


1. Vulnerability: Visibility for constructor

Visibility for constructor is ignored starting solidity version 0.7.0

Recommendation: Please consider removing visibility declaration from the constructor

2. Vulnerability: Public function that could be declared external





 $\underline{\text{public}}$  functions that are never called by the contract should be declared  $\underline{\text{external}}$  to save gas.

Recommendation: Please consider using the  $\underline{\text{external}}$  attribute for functions never called from the contract

Audit report contains all found security vulnerabilities and other issues in the reviewed code.
