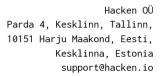

This report presents the findings of the security assessment of the Customer's smart contract and its code review conducted between September $16^{\rm th}$, 2021 - September $27^{\rm th}$, 2021. The second code review conducted on October $4^{\rm th}$, 2021.

Our team performed an analysis of code functionality, manual audit, and automated checks with Mythril and Slither. All issues found during automated analysis were manually reviewed, and important vulnerabilities are presented in the Audit overview section. All found issues can be found in the Audit overview section.

As a result of the audit, security engineers found 3 low severity issues.

After the second review security engineers found that **all** issues were fixed.



Severity Definitions

Risk Level	Description	
Critical	Critical vulnerabilities are usually straightforward to exploit and can lead to assets loss or data manipulations.	
High	High-level vulnerabilities are difficult to exploit; however, they also have a significant impact on smart contract execution, e.g., public access to crucial functions	
Medium	Medium-level vulnerabilities are important to fix; however, they can't lead to assets loss or data manipulations.	
Low	Low-level vulnerabilities are mostly related to outdated, unused, etc. code snippets that can't have a significant impact on execution

1. Missing zero address validation

<u>_treasuryWallet</u>, <u>_communityWallet</u>, <u>_admin</u>, <u>_strategist</u>, and <u>_biconomy</u> aren't validated as being zero-addresses in the initializer. That could lead to the contract's failure.

Recommendation: Please consider adding zero-address validation

Fixed before the second review

2. A public function that could be declared external

public functions that are never called by the contract should be declared external to save gas.

Recommendation: Use the **external** attribute for functions never called from the contract.

3. State variables that could be declared constant

Constant state variables should be declared constant to save gas.

Recommendation: Add the constant attributes to state variables that never change or provide methods to change variables.

Smart contracts within the scope were manually reviewed and analyzed with static analysis tools.

The audit report contains all found security vulnerabilities and other issues in the reviewed code.

As a result of the audit, security engineers found 3 low severity issues.
