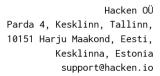

Our team performed an analysis of code functionality, manual audit, and automated checks with Mythril and Slither. All issues found during automated analysis were manually reviewed, and important vulnerabilities are presented in the Audit overview section. All found issues can be found in the Audit overview section.

As a result of the audit, security engineers found 3 low severity issues.

After the second review security engineers found 5 low severity issues.

After the third review security engineers found **all** issues were addressed.



Severity Definitions

Risk Level	Description
Critical	Critical vulnerabilities are usually straightforward to exploit and can lead to assets loss or data manipulations.
High	High-level vulnerabilities are difficult to exploit; however, they also have a significant impact on smart contract execution, e.g., public access to crucial functions
Medium	Medium-level vulnerabilities are important to fix; however, they can't lead to assets loss or data manipulations.
Low	Low-level vulnerabilities are mostly related to outdated, unused, etc. code snippets that can't have a significant impact on execution

1. Unresolved TODOs

There are few TODOs in the source code. That may be assumed that the code is not fully written and some functionality is still unimplemented.

Recommendation: Please implement all TODOs

Status: Fixed.

2. Unused import statements

There is an import in the code which isn't used in the contracts and just burn gas.

Recommendation: Please remove unused imports

Status: Fixed.

3. Maximum line length

According to the <u>solidity style guide</u>: keeping lines under the PEP 8 recommendation to a maximum of 79 (or 99) characters helps readers easily parse the code.

Recommendation: Please follow the style guide

Status: Fixed.

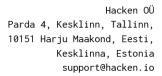
4. Reading the state variable in the loop

Continuously reading the state variable in the loop is causing an unnecessary gas over-usage.

Recommendation: To keep a little gas usage please store the state variable's value to the local variable.

Status: Fixed.

5. A public function that could be declared external





public functions that are never called by the contract should be declared external to save gas.

Recommendation: Use the **external** attribute for functions never called from the contract.

Status: Fixed.



Conclusion

Smart contracts within the scope were manually reviewed and analyzed with static analysis tools.

The audit report contains all found security vulnerabilities and other issues in the reviewed code.

As a result of the audit, security engineers found 3 low severity issues.

After the second review security engineers found 5 low severity issues.

After the third review security engineers found all issues were addressed.
