This report presents the findings of the security assessment of the Customer's smart contract and its code review conducted between January 20<sup>th</sup>, 2022 - January 25<sup>th</sup>, 2022.

## Executive Summary

According to the assessment, the Customer's smart contracts are well-secured.



Our team performed an analysis of code functionality, manual audit, and automated checks with Mythril and Slither. All issues found during automated analysis were manually reviewed, and important vulnerabilities are presented in the Audit overview section. All found issues can be found in the Audit overview section.

As a result of the audit, security engineers found 2 low severity issues.

## Severity Definitions

Risk Level	Description
<b>Critical</b>	Critical vulnerabilities are usually straightforward to exploit and can lead to assets loss or data manipulations.
<b>High</b>	High-level vulnerabilities are difficult to exploit; however, they also have a significant impact on smart contract execution, e.g., public access to crucial functions
<b>Medium</b>	Medium-level vulnerabilities are important to fix; however, they can't lead to assets loss or data manipulations.
<b>Low</b>	Low-level vulnerabilities are mostly related to outdated, unused, etc. code snippets that can't have a significant impact on execution

## Audit overview

No critical issues were found.

No high severity issues were found.

### ■ ■ Medium

No medium severity issues were found.

### ■ Low

1. Unused import statement.

“CraftyFi” imports SafeMath but never uses it in the code.

**Contracts:** CraftyFi.sol

**Recommendation:** It’s recommended not to import libraries while not using them to save gas.

2. No tokenomics in the token.

While provided documents contain tokenomics information, the token code itself doesn’t contain it.

**Contracts:** CraftyFi.sol

**Recommendation:** While the contract is already deployed we’d recommend creating a separate contract that would do vesting tokens in the tokenomics described proportions.



## Conclusion

Smart contracts within the scope were manually reviewed and analyzed with static analysis tools.

The audit report contains all found security vulnerabilities and other issues in the reviewed code.

As a result of the audit, security engineers found **2** low severity issues.
