Executive Summary

Our team performed an analysis of code functionality, manual audit, and automated checks with Mythril and Slither. All issues found during automated analysis were manually reviewed, and important vulnerabilities are presented in the Audit overview section. All found issues can be found in the Audit overview section.

As a result of the audit, security engineers found 1 medium and 2 low severity issues.

Severity Definitions

| Risk Level | Description |
|-----------------|---|
| Critical | Critical vulnerabilities are usually straightforward to exploit and can lead to assets loss or data manipulations. |
| High | High-level vulnerabilities are difficult to exploit; however, they also have a significant impact on smart contract execution, e.g., public access to crucial functions |
| Medium | Medium-level vulnerabilities are important to fix; however, they can't lead to assets loss or data manipulations. |
| Low | Low-level vulnerabilities are mostly related to outdated, unused, etc. code snippets that can't have a significant impact on execution |

1. No events on contract modifications.

While contract modifies its values it is recommended to emit events to give the community better trackage off-chain.

Recommendation: Please make sure all contract modifications are trackable.

Status: Fixed

2. A public function that could be declared external.

public functions that are never called by the contract should be declared **external** to save gas.

Contract: SingularityAirdrop.sol

Function: updateAuthorizer, updateStakingContract, withdrawToken, configureAirDropClaim

Recommendation: Use the external attribute for functions never called from the contract.

Status: Fixed



Conclusion

Smart contracts within the scope were manually reviewed and analyzed with static analysis tools.

The audit report contains all found security vulnerabilities and other issues in the reviewed code.

As a result of the audit, security engineers found **1** medium and **2** low severity issues.

After the second review security engineers found that all issues were addressed.

After the third review security engineers found **no** new issues.
